ICTS Tracing Services provides a full suite of tracing services to enable funds, share schemes and insurers, to meet their commitments to former members, beneficiaries and unclaimed benefits. We continually invest in new technologies that make us more effective and ensure our success rates remain the highest in the industry. Our state of the art call centre staffed by highly experienced, multi-lingual staff is available to assist you in finding past members.

The following levels of tracing are available:

- **Data enhancing** - a high level, electronic enhancement of member data utilising numerous data bases.
- **Member contact and validation tracing** - We will make contact with the former member and verify and capture their telephonic and electronic contact details.
- **Member contact and validation tracing with document collation** - after contacting the traced member, we are able to distribute any documentation the fund may wish to issue (claim forms, requests for information, etc). We will collect and collate the completed documents and provide the fund with a "ready-to-pay" client file.
- **Investigative tracing** - A specialised, more advanced investigative trace to find the member or beneficiary where the initial trace may not have been successful.
- **Investigative tracing with document collation** - the investigative trace together with the additional service of document collection and collation to produce a "ready-to-pay" client file.
- **Confirmation of death** - confirmation of the former member's decease date.
- **Bank verifications** - The verification and validation of an individual's bank account details.
